- 4. Article by Bruce Ellingsen Clarifying the Meaning of "Sustainability" in the Management of the Cortes Community Forest
 - a. Discussion by CCFC Board
 - i. The analogy used is appropriate and easy to understand. It presents a hypothesis that 15% of the annual growth of the forest (Mean Annual Increment - MAI) is a sustainable amount to harvest, which can serve as a basis for further study.
 - ii. More evidence is needed to prove the hypothesis
 - iii. Community support is an important mandate of the Ministry of Forests (MOF) Developing community support through clear, understandable terms fulfils part of our obligations to MOF
 - iv. MOF has accepted our current 5 year plan which closely corresponds to the approach outlined in the article
 - v. Herb Hammond's best educated hypothesis corresponds to 15% annual harvest of MAI. We should seek additional professional advice on this figure. MAI is based on total volume of biomass and not on volume of "usable wood"
 - vi. Traditional methods of establishing MAI were based on recovery from previous logging and Timber Supply Reviews for the Sunshine Coast Forest District
 - vii. LiDAR (Light Detection and Ranging) technology could be a more accurate method of measuring forest cover and improving terrain and watershed data to substantiate our THLB, SEI and harvest rate.
 - viii. Establishing exact percentages may be provocative if MOF parameters differ, but we do have a collective agreement to age our forests over time.

- iii. We need clear terminology, numbers and understanding to unify the community, guide management decisions and justify our approach to MOF and to the community

- v. We can base our final numbers on 3 expert opinions and a clear strategy to test the hypothesis.
- vi. We are charged by our Community Forest Operational Plan (CFP) to act according to our communities wishes
- vii. The CCFC can have a meaningful influence on the CFGP by working on these definitions
